Subject : Filling up vacancies on Direct Recruitment basis for the post of Junior Proof Reader in Lok Sabha Secretariat - Advt. No. 3/2017.

Lok Sabha Secretariat *vide* Advt. No. 3/2017 *inter-alia* notified 06 vacancies [(02 SC, 01 ST and 03 UR)] for the post of Junior Proof Reader on direct recruitment basis in Lok Sabha Secretariat. One vacancy is reserved for physically handicapped persons with Locomotor Disability.

2. The recruitment examination is scheduled to be held on **Sunday, the 14th October, 2018** at Parliament House Annexe, opposite PTI Building/Transport Bhawan (Near Red Cross Society), Parliament Street, New Delhi-110001.

The candidates should report at 09.00 A.M. sharp at Reception Office, Parliament House Annexe, New Delhi on the date of examination. No candidate will be allowed entry into the examination hall after 10.00 A.M.

4. It may please be noted that the answer sheets of the Main Examination of only those candidates will be got evaluated who secure the minimum qualifying marks in the Preliminary Examination.

5. Call letter(s) indicating the minimum qualifying marks and also venue and time of the examination are being issued to the eligible candidates.

6. The lists of eligible as well as ineligible candidates are also being uploaded on Lok Sabha Website : <http://www.loksabha.nic.in> under the heading Recruitment → Advertisements and Notices.

7. The eligible candidates shall reach the venue of examination alongwith a valid ID proof such as PAN Card/Passport/Voter ID/Driving Licence/Aadhaar Card/Permanent Identity Card issued by a University/College or any other valid poof of identification having a latest photograph failing which the candidate may not be allowed to appear in the aforesaid examination.

8. It may please be noted that mobile phone etc. and other electronic devices will not be allowed inside the venue of Examination. The candidates are advised in their own interest NOT to bring these items to the venue of the Examination as no arrangements for safekeeping of these items have been made. Hence, Lok Sabha Secretariat shall not be responsible for any loss in this regard.

Their possession by a candidate in switched on or switched off mode is considered by the Lok Sabha Secretariat as a manipulative practice and will invite cancellation of her/his candidature and/or debarment from the examinations conducted by Lok Sabha Secretariat.
