### REVISION OF PENSION OF EX-MEMBERS OF LOK SABHA

The Ministry of Law & Justice (Legislative Department) *vide* Notification No. 17 of 2018 have notified the Finance Act, 2018 wherein Part V at Sl. No. 141 to 145 (page No. 48) carried out amendments to the Salary, Allowances and Pension of Members of Parliament Act, 1954.

- 2. The following amendments have been made with regard to pension provided to Ex-Members of Parliament; with effect from 1 April, 2018:-
  - **144**. In the principal Act, in section 8A, in sub-section (1),—
    - (a) for the words "twenty thousand rupees", the words "twenty-five thousand rupees" shall be substituted;
    - (b) in the proviso, for the words "fifteen hundred rupees", the words "two thousand rupees" shall be substituted;
    - (c) after the proviso, the following sub-section shall be inserted, namely:—
      - "(1A) The pension and additional pension to every person shall be increased after every five years commencing from 1st April, 2023 on the basis of Cost Inflation Index provided under clause (v) of Explanation to section 48 of the Income-tax Act, 1961."
  - **145**. In the principal Act, in section 8AC, in sub-section (2), the words, brackets and figures "before the commencement of the Salary, Allowances and Pension of Members of Parliament (Amendment) Act, 2006" shall be omitted and shall be deemed to have been omitted with effect from the 15th day of September, 2006.

3. Accordingly, Ex-Members of Lok Sabha are hereby informed that pension of Ex-MPs has been enhanced w.e.f. 1<sup>st</sup> April, 2018 from Rs. 20,000/- to Rs. 25,000/- per mensem and for a period exceeding five years, there shall be paid to an Ex-MP an additional pension of Rs. 2000/- per mensem for every year served in excess of five years. To get the revised pension, Ex-MPs are required to fill-in application for revision of pension and a declaration form in accordance with the recent amendment in the Salary, Allowances and Pension of Members of Parliament Act, 1954 (also uploaded on Lok Sabha Website).
