Terms & Conditions for X-Ray Baggage Inspection Systems

- 01. Bids are invited from established, reputed and experienced original manufacturers or their authorized distributors, Governmental/Semi-Governmental Organizations and Public Sector Undertakings having minimum annual turnover of Rs. 15 (fifteen) crore for the last three years for supply, installation and commissioning of 10 Nos. of X-Ray Baggage Inspection Systems (8 Nos. of single view tunnel size 620 mm x 420 mm ±5%, 1 No. of dual view tunnel size 620 mm x 420 mm ±5% and 1 No. of dual view tunnel size 1000 mm x 1000 mm)±5% in Parliament of India. The bidding firms should furnish relevant documents as proof of minimum turnover requirement for the last 3 years and Income Tax Return files status, Service Tax and VAT Registration Number, Name of Departments/Ministry/Government Organizations, where the firms supplied similar items earlier, status on Black listing by any Government agency etc.
- 02. The bidding firm should have supplied the XBISs to any Governmental / Semi Governmental department and delivery confirmation certificate should be furnished in the support.
- 03. All bidders participating in the Tender must submit a list of their owners, partners etc. and certificate to the effect that the firm is neither blacklisted by any Government Department nor any Criminal Case is registered against the firm or its owner or partners or directors anywhere in India.
- 04. Bidder must state categorically whether or not his offer conforms to all the tender terms and conditions. If there is a variation in any of the terms and conditions, the extent of variation and the reasons thereof shall be clearly mentioned in the technical bid.
- 05. It will be imperative on each bidder to fully acquaint himself with all the local conditions and factors, which would have any effect on the performance of the contract and cost of the stores. No request for the change of price or time schedule of the delivery of stores shall be entertained, on account of any local condition or factor once the offer is accepted by the Purchaser.
- O6. Any activity of influencing the procurement process may result into rejecting of bid/cancellation of purchase order/forfeiting of performance security along with banning of firm for participation in future tenders of Lok Sabha Secretariat.
- 07. Any information related to procurement including participation of your firm should not be published or advertised for any purpose whatsoever.
- 08. Bidders are advised to study the tender documents thoroughly. Submission of tender shall be deemed to have been done after careful study and examination of the tender documents with full understanding of its implications.
- 09. Lok Sabha Secretariat reserves the right to relax any of the Terms and Conditions.

- 10. Bidders should not ask middlemen/agents/commission agents etc to represent their cause.
- 11. Conditional bids, Telex/Fax bids and incomplete bids will summarily be rejected.
- 12. Prices should be quoted in Indian Rupees and F.O.R Lok Sabha Secretariat.
- 13. The prices should be excluding of all taxes/duties, civil, electrical and miscellaneous work involving installation and commissioning charges. Charges for civil work, electrical work, miscellaneous work, installation and commissioning may be shown separately item wise as per Appendix "A". Lok Sabha Secretariat will pay all applicable taxes & duties at actual. No tax/duty exemption certificates will be provided by LSS.
- 14. The offers should be valid for 180 days from the date of opening of tender.
- 15. Bids must be accompanied with Bid Security (Earnest Money) of ₹12,50,000/- (Rupees Twelve Lakh Fifty Thousand only) in the form of Demand Draft/ Fixed Deposit Receipt /Banker's Cheque or Bank Guarantee from any of the commercial banks drawn in favour of "Drawing & Disbursing Officer, Lok Sabha, New Delhi" in an acceptable form. The bid security should remain valid for a period of forty five days beyond the final bid validity period i.e., 180 days from the date of opening of tenders. No interest will be paid on Earnest Money. Bids not accompanied by Earnest Money will not be considered.
- 16. Bidder(s) registered with DGS&D and NSIC are exempted from furnishing bid security and to avail it, supporting certificate of registration with DGS&D/ NSIC along with list of registered items should be submitted with the bid. System offered in the bid must be amongst the items registered with DGS&D/ NSIC.
- 17. Performance Security @10% of the contract value in the form of Account payee Demand Draft or Fixed Deposit Receipt from a Commercial bank or Bank Guarantee from a commercial bank in an acceptable from will have to be furnished by successful bidder within seven days after receipt of award of contract irrespective of their registration status with DGS&D/ NSIC etc.
- 18. The Performance Security should be valid for a period of sixty days beyond all contractual obligations including warranty and AMC obligations i.e. 10 years (3 years warranty and 7 years AMC period) from the date of final acceptance, installation and commissioning of the equipments. Performance Security will be released after satisfactory completion of warranty and AMC period.
- 19. Bid security (EMD) of the successful bidder will not be refunded until furnishing of the Performance Security as mentioned above.
- 20. Bid securities of the unsuccessful bidder(s) will be returned within 30 days after the award of the contract of procurement.

- 21. The EMD/Bid Security shall be forfeited:
 - a. If a bidder withdraws his bid during the period of bid validity; or
 - b. In case the finally selected bidder, fails:
 - i. to sign the contract in accordance with terms and conditions of this tender.
 - ii. to furnish Performance Security.
 - c. If at any stage any of the information/ declaration is found false.
- 22. Bidder should seal the Technical bid and Financial bid in two separate covers superscribed as "Technical bid" and "Financial bid" respectively and should be placed inside a larger sealed cover superscribed as "Tender for supply of 10 Nos. of X-Ray Baggage Inspection Systems". EMD/Bid Security may be placed in larger cover. In the Technical bid, the bidder must submit all the relevant details for alternative/optional items offered. In the Financial bid, price (item wise) and rate of applicable taxes should be mentioned separately for comparison and finding out L-1 easily. The rates should be quoted as per Appendix-A.
- 23. Partial bids will not be accepted. The tender is for supply and installation of 10 Nos. of X-Ray Baggage Inspection Systems (8 Nos. of single view and 2 Nos. of dual view) in Parliament of India, New Delhi.
- 24. Bidder(s) should ensure availability of after sales service and spare parts. All bidder(s) should give an undertaking that they would render after sales service and supply of spares throughout the declared life of the equipment i.e. ten years from the date of supply, installation and commissioning to this secretariat. Technical Team of secretariat may visit the firm to ensure availability of infrastructure meant to provide after sales service. The firm should also provide complete operational training of the equipment to the concerned staff members of this secretariat at no extra cost.
- 25. The tender is for supply of new X-Ray Baggage Inspection Systems. Only those firms who are in a position to give live demonstration of the equipment offered within 04 (four) weeks of notice and deliver the equipments within 08 (eight) weeks of signing of agreement between LSS and successful bidder (L1) should furnish their bids. The installation, testing and commissioning of the proposed system shall be completed within a period of 02 (two) weeks after the delivery of the stores at Parliament of India premises or within a period of 10 (ten) weeks from the date of award of the contract whichever is earlier. Equipments supplied by the successful bidder will be inspected by authorized officials of Parliament Security Service, LSS and payment will be released only on the basis of their inspection certificate.
- 26. The successful bidder shall hand over to LSS the installation, operation, repair and maintenance manuals of the equipment at no extra cost. This includes User manuals & Equipment Maintenance Manual.
- 27. If the supplier fails to perform any of the services of contract within the time period specified in the tender, the Purchaser shall, without prejudice to its other remedies under the tender, deduct from the Performance security, by way of penalty, a sum equivalent to two (2) % of **cost of the equipment** per week (part of a week being treated as full week) of delayed delivery or unperformed service until actual delivery or performance, up to a maximum deduction of 20% of

- cost of the equipment(s). In the event of delay in performing any of the services of contract more than 10 weeks, the firm shall be debarred from taking part in future tenders of LSS.
- 28. In case bidder(s) is/are a distributor(s), a copy of **authorized dealer** certificate issued by the principal firm should be enclosed.
- 29. Bidders should supply technical literature / manual of the equipment(s) and list of Govt. customers with their detailed addresses.
- 30. Bidder(s) should quote on their letter pads. Supporting documents/certificates in respect of VAT/Sale Tax/Service Tax Registration No. should be submitted with the bids.
- 31. Successful bidder shall have to enter into an agreement with Lok Sabha Secretariat within 21 days of the issue of letter of acceptance. The agreement shall contain technical specifications, time schedule, payment schedule, warranty, AMC after warranty and penalty for delay in completion or violation of terms and conditions.

32. **Guaranty/ Warranty**

- i. The supplier shall provide on-site warranty for three years. The period of comprehensive onsite warranty will commence from the date of installation, testing, commissioning, handing/taking over and satisfactory functioning of the system certification by the authorized officials of PSS.
- ii. The supplier must have a maintenance base in Delhi to provide maintenance service, of the system being offered, efficiently and promptly.
- iii. If the performance of any individual equipment fails to meet the contract specifications then the same shall be replaced by the supplier free of cost during the terms of warranty period within the time stipulated by the Lok Sabha Secretariat.
- iv. Guaranty / Warranty will be comprehensive i.e. inclusive of all spare parts/consumables if any.
- v. Breakdown has to be attended within half an hour of complaint.
- vi. In case of major defects requiring the defective equipment to be taken to supplier's workshop, a suitable working substitute unit will have to be provided by the supplier. The to and fro transportation of the equipment will be responsibility of supplier.
- vii. Service Engineer has to be made available by the supplier in Parliament House complex during the normal working hours except on Sunday and GH. Preventive Maintenance will be carried out once in every 03 (three) months.

33. Full Service Maintenance Agreement (FSMA) or AMC:

- a) AMC will be comprehensive i.e. inclusive of all spare parts including consumables, if any.
- b) Bidder(s) should quote for AMC for a period of seven years. For calculation of AMC, cost of civil work, electrical work, miscellaneous work, installation and commissioning should not be included. Total order value of AMC may be given as per **Appendix "B"**.
- c) The AMC charges would be considered as a criterion for deciding the lowest bidder. AMC period will start after expiry of Guaranty/ Warranty period. Payment of AMC charges will be made on half yearly basis after completion of each half year and submission of bill for that period, subject to the supplier rendering the maintenance services efficiently and to the complete satisfaction of the purchaser for the said half year.
- d) No advance payment will be made for AMC.

e) **Penalty clause:**

- i) Response time after information Within half an hour.
- ii) Maximum time for repair Two days. AMC charges of the delayed period will not be paid if the delay is more than 6 hours from the specified time limit on pro-rata basis.
- iii) If the supplier fails to repair the equipment(s) within the time period specified in the tender, the Purchaser shall, without prejudice to its other remedies under the tender, deduct either from the AMC charges or from the Performance Security by the way of penalty, a sum equivalent to 2% (two percent) of the **cost of the equipment(s)** per week (part of week being treated as full week) of delay until actual performance in addition to non-payment of pro-rata maintenance charges for the period during which machine remains non-functional. The penalty shall be deducted first from the AMC charges. In case AMC is not available then penalty shall be deducted from performance security.
- f) If the supplier fails repair or replace any of the defective equipment(s), Lok Sabha Secretariat (LSS) will be free to get it repaired/ replaced from the market and its cost will be adjusted from the Performance Security or outstanding dues of the supplier.
- g) Supplier will have to enter into agreement with Lok Sabha Secretariat regarding permissible down time during warranty/AMC period and penalty for delay in maintenance services.
- 34. - 35. A pre-bid meeting with the prospective bidders will be held in the Office of the Additional Director (Technical), Lok Sabha Secretariat, Parliament House, New Delhi-110001, on 20-11-2015 at 1500 hrs for clarifying the doubts if any at one time. Clarifications given in the pre-bid meeting shall be uploaded on Lok Sabha homepage on the next working day which shall be binding for all prospective bidders. No separate correspondence shall be made with prospective bidders in this regard.
- 36. At the first instance only Technical bids will be opened on 08-12-2015 at 1500 hrs in the Office of the Additional Director (Technical), Lok Sabha Secretariat, Room No.47, Parliament House, New Delhi-110001 in the presence of bidder(s) or their representatives who desire to be present at the occasion with prior intimation to this secretariat on Phone No. 011-23035279 latest by 1330 hrs on 08-12-2015.
- 37. After evaluation of the technical bids, shortlisted bidder(s) will be intimated. The short listed bidder(s) would be required to give the live demonstration of the equipment offered in Parliament House Complex or in their office/workshop. The decision of the Technical Committee on technical suitability of the offer shall be final and shall not be open for discussion.
- 38. The financial bids of the only technically qualified bidder(s) will be opened in the office of P&AO, Parliament House Annexe, New Delhi in presence of bidder(s) or their representative, if they desire so. The date and time of opening of financial bids will be intimated to the short listed bidder(s).
- 39. Prices after adding AMC charges for seven years and the total price will be considered for deciding L-1.
- 40. The payment towards procurement and installation etc. shall be made only after installation, commissioning, integration, handing/taking over of the equipment(s) and satisfactory performance certification by PSS. All bills shall be raised in Indian rupees and payments shall also be made in Indian rupees.
- 41. The commissioning or installation shall not be deemed to have been completed unless all the systems are accepted by the LSS. After installation an Acceptance Test will be carried out at the location of installation and the equipment that meets the acceptance test will only be accepted.
- 42. The Secretariat reserves the right to vary the quantities and /or split the order among the selected bidder(s) along with right to relax any of the Terms & Conditions.
- 43. The Secretariat reserves the right to accept or reject any or all tender(s) without assigning any reason whatsoever at any stage of the procurement process.
- 44. Disputes, if any, emanating from the resultant contract will be interpreted under the Indian Laws. All disputes shall be subject to jurisdiction of courts of Delhi only.

45. **Force Majeure**: The Contractor shall not be liable for forfeiture of its performance security, liquated damages or termination for default, if the delay in performance or other failure to perform its obligation under the contract is a result of an event of Force Majeure. Such events may include wars or revolutions, fires, floods, epidemics, quarantine restrictions, freight embargoes etc. Lok Sabha Secretariat will decide whether delay or failure on the part of the supplier was the result of an event beyond his control or not. The decision of Lok Sabha Secretariat in this regard shall be final and binding on the supplier and will not be open to question before any court/forum in any proceedings.

TECHNICAL SPECIFICATION OF XBIS SINGLE VIEW (TUNNEL SIZE 620 mm x 420 mm)

- **1. Tunnel Size:** 620 mm W (Width) x 420 mm H (Height) ± 5%.
- **2. Operating Voltage**: All machines should operate on 230 VAC, 50 Hz power supply & should be able to withstand voltage fluctuations in the range of 170V- 260 V. Single Phase, 3 to 5 Amp.
- **3. Operating temperature:** should be -0° C to 50° C & storage temperature -20°C to 50° C.
- **4. Humidity** 90% non-condensing.

5. Conveyor belt:

- 5.1 Conveyor belt speed should be between 0.18 and 0.3 meter per second. Conveyor movement should be bi-directional.
- 5.2 Conveyor belt should stop automatically in the absence of baggage after 3 minutes. Stop timing should preferably be user adjustable.
- 5.3 Conveyor Capacity- 100 kg or more.

6. X-Ray Source/Generator:

- 6.1 X-Ray Generator Voltage 160 KV or more.
- 6.2. X-Ray Source/Generator It should be capable to operate smoothly for a period of at least six years.
- 6.3 The X-ray beam divergence should be such that the complete image at maximum size of bag is displayed without corner cuts.
- 6.4 Duty Cycle 100%.
- 6.5 Cooling Sealed oil bath.
- 6.6 Protection: Protection against over voltage/power surge/ over temperature should be available. Protection system should cover entire installation including equipment, X-Ray Generators, power supply equipment, computer systems etc.

7. Resolution, Detection and Penetration:

7.1 The machine should be able to display single un-insulated tinned copper wire of 42-SWG or 38 AWG. All penetration and resolution condition should be met without pressing any functional key and should be online.

- 7.2 Penetration should be 27 mm thickness of steel (Guaranteed) or more.
- 7.3 Should be capable of **detecting liquid explosives and hazardous materials**.

8. Audio-Video Alarm:

- 8.1 The machine should give audio and video alarm upon detection of high density organic materials including explosives and narcotics, should have variable colour or materials stripping to facilitate the operator to monitor images for closer scrutiny. All suspicious items (Explosives, High density materials, narcotics, etc.) should be displayed in one mode and that should be on line.
- 8.2 If the machine fails to penetrate a particular item then an alarm video and audio (both) should be generated to notify the operator.
- **9.** <u>Video display Unit:</u> VDU should be 17" or better LED Monitor of High resolution, low radiation, flicker free, resolution at least 1280 x 1024 or better, 24 bit colour real time processing.

10. Safety features:

- 10.1 Radiation Safety: The machine must comply with requirements of health and safety regulations with regard to mechanical, electrical and radiation hazards. Before installation of the machine, the supplier/manufacturer should furnish relevant certificate from Atomic Energy Regulatory Board of India regarding radiation safety. The company manufacturing the equipment should have ISO certification for manufacturing and servicing of X-ray Screening machines.
- 10.2 Food and Film Safety: Guaranteed safety for food and high-speed films up to ISO1600. The machines should be film safe. In other words photographic films must not be damaged due to x-ray examination.
- 10.3 Lead impregnated safety screens should be available at either ends of the tunnel. This should be covered by relevant AERB certificate.
- 10.4 The radiation level should not exceed accepted health standard (0.1m R/hr at a distance of 5 cm from external housing).
- 10.5 Emergency stop buttons should be provided at either ends of system.

11. Software features:

- 11.1 All software features of machine should be online and password protected.
- 11.2 The machine should be so designed that software enhancement can be easily implemented to take care of new technique in image processing and pattern recognition.

- 11.3 Copy of all software including X-Ray Software with recovery DVD must be provided.
- 11.4 All software features should be controlled from key board of machine only. Keyboard function should be user friendly. To enable/disable the software features, system should not be rebooted.

12. Image:

- 12.1 Machine should be capable for recalling 15 or more previous images,
- 12.2 It should have the capability of archiving 4000 or more images with date & time stamp.
- 12.3 Facility of image enhancement should be available.
- 12.4 Facility for variable contrast must be incorporated to allow enhancement lighter and darker portion of the image.
- 12.5 Machine should have online recording facility and images can be recorded in DVD R/W or/and USB and should be able to view images so recorded on stand-alone PC.
- 12.6 The machine should have features of Multi-energy X-ray imaging facility where materials of different atomic number will be displayed in different colours to distinguish between organic and inorganic materials.
- 12.7 Continuous Electronic Zoom facility should be available to magnify the chosen area of an image eight times (8X) or more. Image features shall be keyboard controllable.

Bidder should seal the Technical bid and Financial bid in two separate covers superscribed as "Technical Bid" and "Financial Bid" respectively and should be placed inside a larger sealed cover superscribed as "Tender for supply of 01 No. of Liquid Explosive Detectors". EMD/Bid Security may be placed in larger cover. In the Technical bid, the bidder must submit all the relevant details for alternative/optional items offered. In the Financial bid, price (item wise), rate of applicable taxes and charges should be mentioned separately for comparison and finding out L1 easily. The rates should be quoted as per Appendix-A.
- 23. Bidder(s) should ensure availability of after sales service and spare parts. All bidder(s) should give an undertaking that they would render after sales service and supply of spares throughout the declared life of the equipment i.e. ten years from the date of supply and commissioning. Technical Team of secretariat may visit the firm to ensure availability of infrastructure meant to provide after sales service. The firm should also provide complete operational training of the equipment to the concerned staff members of this secretariat at no extra cost.
- 24. The tender is for supply of new Liquid Explosive Detector. Only those firms who are in a position to give live demonstration of the equipment offered within 04 (four) weeks of notice and deliver the equipments within 08 (eight) weeks of signing of agreement between LSS and successful bidder (L1) should furnish their bids. The installation, testing and commissioning of the proposed system shall be

completed within a period of 02 (two) weeks after the delivery of the stores at Parliament of India premises or within a period of 10 (ten) weeks from the date of award of the contract whichever is earlier. Equipments supplied by the successful bidder will be inspected by authorized officials of Parliament Security Service, LSS and payment will be released only on the basis of their inspection certificate.

- 25. The successful bidder shall hand over to LSS the installation, operation, repair and maintenance manuals of the equipment at no extra cost. This includes User manuals & Equipment Maintenance Manual.
- 26. If the supplier fails to perform any of the services of contract within the time period specified in the tender, the Purchaser shall, without prejudice to its other remedies under the tender, deduct from the Performance security, by way of penalty, a sum equivalent to two (2) % of **cost of the equipment** per week (part of a week being treated as full week) of delayed delivery or unperformed service until actual delivery or performance, upto a maximum deduction of 20% of cost of the equipment(s). In the event of delay in performing any of the services of contract more than 10 weeks, the firm shall be debarred from taking part in future tenders of LSS.
- 27. In case bidder(s) is/are a distributor(s), a copy of authorized dealer certificate issued by the principal firm should be enclosed.
- 28. Bidders should supply technical literature / manual of the equipment(s) and list of Govt. customers with their detailed addresses.
- 29. Bidder(s) should quote on their letter pads. Supporting documents/certificates in respect of VAT/Sale Tax/Service Tax Registration No. should be submitted with the bids.
- 30. Successful bidder shall have to enter into an agreement with Lok Sabha Secretariat within 21 days of issue of letter of acceptance. The agreement shall contain technical specifications, time scheduled, payment schedule, warranty, AMC after warranty and penalty for delay in completion or violation of terms and conditions.

31. Guaranty/Warranty

i. The supplier shall provide on-site warranty for three years. The period of comprehensive onsite warranty will commence from the date of installation, testing, commissioning, handing/taking over and satisfactory functioning of the system certification by the authorized officials of PSS.

- ii. The supplier must have a maintenance base in Delhi to provide maintenance service, of the system being offered, efficiently and promptly.
- iii. If the performance of equipment fails to meet the contract specifications then the same shall be replaced by the supplier free of cost during the terms of warranty period within the time stipulated by the Lok Sabha Secretariat.
- iv. Guaranty / Warranty will be comprehensive i.e. inclusive of all spare parts/consumables if any.
- v. Breakdown has to be attended within half an hour of complaint.
- vi. In case of major defects requiring the defective equipment to be taken to supplier's workshop, a suitable working substitute unit will have to be provided by the supplier. The to and fro transportation of the equipment will be responsibility of supplier.
- vii. Preventive Maintenance will be carried out once in every 03 (three) months.

32. Full Service Maintenance Agreement (FSMA) or AMC:

- a) AMC will be comprehensive i.e. inclusive of all spare parts, re-chargable batteries and consumables, if any.
- b) Bidder(s) should quote for AMC for a period of seven years. For calculation of AMC, cost of civil work, electrical work, miscellaneous work, installation and commissioning should not be included. Total order value of AMC may be given as per Appendix 'B'.
- c) The AMC charges would also be considered as a criterion for deciding the lowest bidder. AMC period will start after expiry of Guaranty/ Warranty period. Payment of AMC charges will be made on half yearly basis after completion of each half year and submission of bill for that period, subject to the supplier rendering the maintenance services efficiently and to the complete satisfaction of the purchaser for the said half year.
- d) No advance payment will be made for AMC.

e) Penalty clause:

i) Response time after information – Within half an hour.

- ii) Maximum time for repair Two days. AMC charges of the delayed period will not be paid if the delay is more than 6 hours from the specified time limit on prorata basis.
- iii) If the supplier fails to repair the equipment within the time period specified in the tender, the Purchaser shall, without prejudice to its other remedies under the tender, deduct either from the AMC charges or from the Performance Security by the way of penalty, a sum equivalent to 2% (two percent) of the **cost of the equipment** per week (part of week being treated as full week) of delay until actual performance in addition to non-payment of pro-rata maintenance charges for the period during which machine remains non-functional. The penalty shall be deducted first from the AMC charges. In case AMC is not available then penalty shall be deducted from performance security.
- f) If the supplier fails repair or replace the defective equipment, Lok Sabha Secretariat (LSS) will be free to get it repaired/ replaced from the market and its cost will be adjusted from the Performance Security or outstanding dues of the supplier.
- g) Supplier will have to enter into agreement with Lok Sabha Secretariat regarding permissible down time during warranty/AMC period and penalty for delay in maintenance services.
- 33. Sealed Tenders superscribing "<u>Tender for Liquid Explosive Detector</u>" complete in all respects and addressed to <u>The Joint Secretary (Security)</u>, <u>Lok Sabha Secretariat</u>, <u>Room No.108</u>, <u>Parliament House</u>, <u>New Delhi-110 001</u> should reach this Secretariat latest by 1300 hrs on 08-12-2015.
- 34. A pre-bid meeting with the prospective bidders will be held in the Office of the Additional Director (Technical), Lok Sabha Secretariat, Parliament House, New Delhi-110001, on 20-11-2015 at 1500 hrs for clarifying the doubts if any at one time. Clarifications given in the pre-bid meeting shall be uploaded on Lok Sabha homepage on the next working day which shall be binding for all prospective bidders. No separate correspondence shall be made with prospective bidders in this regard.
- 35. At the first instance only Technical bids will be opened on 08-12-2015 at 1500 hrs in the Office of the Additional Director (Technical), Lok Sabha Secretariat, Parliament House, New Delhi-110001 in the presence of bidder(s) or their representatives who desire to be present at the occasion with prior intimation to this secretariat on Phone No. 011-23035279 latest by 1330 hrs on 08-12-2015.

- 36. After evaluation of the technical bids shortlisted bidder(s) will be intimated. The short listed bidder(s) would be required to give the live demonstration of the equipment offered in Parliament House Complex at their own cost. The decision of the Technical Committee on technical suitability of the offer shall be final and shall not be open for discussion.
- 37. The financial bids of the only technically qualified bidder(s) will be opened in the office of P&AO, Parliament House Annexe, New Delhi in presence of bidder(s) or their representative, if they desire so. The date and time of opening of financial bids will be intimated to the short listed bidder(s).
- 38. Prices after adding AMC charges for seven years will be considered for deciding L-1.
- 39. The payment towards procurement and installation etc. shall be made only after installation, commissioning, integration, handing/taking over of the equipment(s) and satisfactory performance certification by PSS. All bills shall be raised in Indian rupees and payments shall also be made in Indian rupees.
- 40. The commissioning or installation shall not be deemed to have been completed unless all the systems are accepted by the LSS. After commissioning or installation an Acceptance Test will be carried out at the location of installation and the equipment that meets the acceptance test will only be accepted.
- 41. The Secretariat reserves the right to vary the quantities and /or split the order among the selected bidder(s) along with right to relax any of the Terms & Conditions.
- 42. The Secretariat reserves the right to accept or reject any or all tender(s) without assigning any reason whatsoever at any stage of the procurement process.
- 43. Disputes, if any, emanating from the resultant contract will be interpreted under the Indian Laws. All disputes shall be subject to jurisdiction of courts of Delhi only.
- 44. **Force Majeure**: The Contractor shall not be liable for forfeiture of its performance security, liquated damages or termination for default, if the delay in performance or other failure to perform its obligation under the contract is a result of an event of Force Majeure. Such events may include wars or revolutions, fires, floods, epidemics, quarantine restrictions, freight embargoes etc. Lok Sabha Secretariat will decide whether delay or failure on the part of the supplier was the result of an event beyond his control or not. The decision of Lok Sabha Secretariat in this regard shall be final and binding on the supplier and will not be open to question before any court/forum in any proceedings.
