TERMS AND CONDITIONS OF THE TENDER

DISPOSAL OF TWO CONDEMNED LETTERPRESS PRINTING MACHINES ALONG WITH THEIR SPARE PARTS, CONSUMABLES AND ACCESSORIES

- 1. Bids may be submitted in the enclosed prescribed Proforma (Annexure-I).
- 2. Bids are invited only from the firms registered with Delhi Pollution Control Committee (Electronic Waste Management in Delhi) dealing with E-waste etc. and having its Office (head office/ regional/Branch Office) in Delhi/NCR (a copy of valid registration certificate should be attached). Bids received from the firms other than registered will be summarily rejected.
- 3. Bids should remain valid for acceptance for a period of three months from the date of opening of the Bids. Bids with lesser validity period will be summarily rejected.
- 4. Sealed tenders superscribed "Tender for disposal of two condemned Letter Press Machines along with their spare parts, consumables and accessories' addressed to the Director (GPS&SCTC), General Procurement Branch, Lok Sabha Secretariat, Room No.408, Parliament House Annexe, New Delhi, must reach on or before 16.12.2015 by 1500 hrs. Tenders may be hand delivered at the afore-mentioned address. Bids received after the closing date and time prescribed shall NOT be accepted under any circumstances.
- 5. The Earnest Money Deposit (EMD) of Rs. 10,000/- (Rupees Ten Thousand only) in the form of Demand Draft/Banker Cheque drawn in favour of 'Drawing and Disbursing Officer, Lok Sabha' payable at New Delhi must accompany the Bid. Bids without EMD/EMD for fewer amounts and EMD in any other form e.g. Cheque, Cash, Postal Order will be summarily rejected. The submission of EMD is compulsory for all the bidders and no exemption will be granted for submission of EMD in any case. EMD will be forfeited if the bidders withdraw after submission of the bids or opening of the tenders. EMD furnished by all unsuccessful bidders will be returned to them without any interest whatsoever, after final disposal of the material. The EMD should remain valid for a period of 90 days.
- 6. Materials should be removed by the successful bidder on "as is where is basis" within five days of receipt of order after depositing the full amount in the form of Bank Draft/ Banker's Cheque drawn in favour of 'Drawing and Disbursing Officer, Lok Sabha

payable at New Delhi. EMD shall be returned after the condemned material is removed as per terms & conditions laid down. In case, the material is not removed within the prescribed time, the Earnest Money will be forfeited and any loss whatsoever occurring due to this will be recovered from the bidder. In case, the successful bidder deposits the full amount within a stipulated period but fails to lift the articles, this Secretariat shall not take responsibility for safe custody of the articles.

- 7. The inspection of material should be done carefully by the prospective bidders or their representatives at Rotaprint Section of Lok Sabha Secretariat, 36, GRG Road, New Delhi 110001 (Phone No. 011-2303 4283), between 3:00 P.M. to 5:00 P.M. from 07.12.2015 to 15.12.2015 and queries should be raised to the concerned Officer at the time of inspection. No further clarifications shall be given after the above inspection.
- 8. No damage should be caused to the existing property of this Secretariat or any other Offices in the premises while removing the materials from the site. Any loss/damage to the property of this Secretariat or any other Offices in the premises or injury or personal accident suffered by any person due to negligence or action of the successful bidder or his authorized worker/supervisor will have to be indemnified by the successful bidder.
- 9. Goods/material will be removed under the supervision of designated Officer (s) of this Secretariat. Materials will have to be removed within the time stipulated in the order awarding disposal of items to the successful bidder. No extension of time will be given under ordinary circumstances. However, extension of time may be granted provided full reasons for causing such delay is given in writing by the successful bidder. Delay, beyond the stipulated time, may entail cancellation of the award/order and forfeiture of the EMD.
- 10. The successful bidder will have to take away all Condemned/scrapped listed items and not selectively.
- 11. All the bidders shall ensure compliance with the provisions contained in existing E-Waste (Management and Handling) Rules and guidelines issued by Government for its disposal/recycling in an environment friendly manner.
- 12. The incomplete and conditional tenders will be rejected.
- 13. No bidder will be allowed to withdraw after submission of bids/opening of the tender; otherwise the EMD submitted by the firm would be forfeited.
- 14. This tender is non transferable.

- 15. All the labour charges towards loading, uploading and transportation charges, etc. shall be borne by the successful bidders. No claims and complaint whatsoever will be entertained on account of lifting and transportation.
- 16. If any tenderer finds any irregularity or omission or is in doubt he should at once intimate the **Lok Sabha Secretariat** in writing and obtain clarification in writing 7 days prior to submission of the tender. Verbal clarification given by any of the staff shall not be binding on the **Lok Sabha Secretariat**.
- 17. If a firm violates any of these terms & conditions, it shall be blacklisted and its EMD shall be forfeited.
- 18. Lok Sabha Secretariat reserves the right to accept or reject any bid without assigning or communicating any reason thereof.
