- 2. The auction would be held separately for each vehicle. The terms and conditions of the sale are as under: -

 - (ii) Before commencement of the auction, every intending bidder will have to deposit for each vehicle a sum of Rs. 10,000/- between 0930 hours and 1045 hours in cash which will be refunded to the unsuccessful bidder after the auction proceedings are over.
