Technical Specifications of Hand Held Metal Detector

1. **Dimension:** Length : Maximum 500 mm
Probe width : Maximum 120 mm
Body width : Maximum 65 mm
2. **Weight** Maximum : 500 gms (with battery)
3. **Power source** Alkaline battery 9 volt and should run minimum 100 hours
4. **Battery Protection** To be provided against damage due to reverse polarity
5. **Indication** Single LED based audio and visual multiple indication for:
Switch on
Metal detection
Low battery indication
6. **Operation** Single push button operation
7. **Construction** Should be rugged and impact resistant ABS moulded casing
8. **Scan Rate** Minimum 3" to 24" per second
9. **Detection** Should be able to detect ferrous and no-ferrous metals
Pistol .22 at minimum 6"
Cartridge .22 minimum at 2"
Razor Blade at minimum 1"
10. **Tuning** Automatic to ensure equal result on wide range of metals and alloys
11. **Operating Temperatures** -10 to + 55 Celsius.
Humidity 0 to 95 % non-condensing.
12. **Safety** The detector should be safe for people with pacemakers and should not affect magnetic recording media.
13. **Warranty** 2 years from the date of supply
14. **Life of Equipment** Minimum 5 years
15. **Miscellaneous** The firm should be able to provide the following, as applicable, along with the equipment:
Cleaning kit
Technical Manual giving full description of equipment
User's Hand Book

Terms & Conditions for Hand Held Metal Detector

1. All tenders must be legible, correct and signed by the tenderers. Tenders containing overwriting/alteration will be summarily rejected unless countersigned by authorized signatory.
2. Prices should be quoted in Indian Rupees (both in figures and words) and F.O.R. Lok Sabha Secretariat.
3. The prices should be inclusive of all taxes/duties prevalent at the time of furnishing tender(s) and should be valid for 180 days from the date of opening of tenders.
4. The bidders must enclose an undertaking stating that he or his firm has not been debarred from bidding by any government organization.
5. The tenders should be accompanied with Earnest Money @ 5% of the total cost of equipments in the form of “Demand Draft” drawn in favor of “Drawing & Disbursing Officer, Lok Sabha Secretariat” and payable at New Delhi. Tenders without Earnest Money will be summarily rejected. Earnest Money of the successful tenderer(s) will be retained as security deposit/performance security and will be refunded to the successful bidder on receipt of Performance Security @10% of the contract value in the form of bank guarantee. No interest shall be payable on the earnest money deposited by the bidders.
6. The firms submitting quotations may give buyback offer for 50 Nos. of Hand Held Metal Detector Model: “GARRETT ENFORCER” to Lok Sabha Secretariat on as & where is basis. The buy-back offer price will be deducted from the quoted price of that particular firm for comparison of rates with other qualified competitive bidders.
7. The bidder is to submit tender bid in two parts, in separate covers. One containing the Technical bid and the other containing the Financial bid /Price bid clearly mentioned on the covers. The sealed Technical and Price bids should be placed inside a large sealed cover. In the Technical bid the bidder must submit all the relevant details for alternative/optional items offered.
8. The tenderers should ensure availability of after sales service, consumables if any, rechargeable batteries if installed and spare parts. All the tenderers should give an undertaking that they would render after sales service, supply of spares throughout the declared life of the equipment i.e. minimum seven years from the date of supply to this Secretariat. The firm should also provide complete operational training of the equipment to the concerned staff members of this secretariat at no extra cost.
9. Only those firms who are in a position to arrange a working demonstration of the equipment(s) offered within 15 days notice and supply the said Nos. of equipments within 30 days after the placement of supply order should furnish their offer.
10. There should not be any type of deviation with regard to Technology, design, dimension etc. between equipment offered and supplied.

11. In case Tenderer(s) is/are a distributor(s), a copy of certificate issued by the principal firm should be enclosed.
12. Technical literature / Manual on the equipment(s) and list of customers with their detailed addresses should be sent along with tenders.
13. Tenderer(s) should quote on their letter pads. Copy of latest income tax clearance certificate should also be attached.

AMC:

- (a) Tenderer(s) should quote for comprehensive AMC for a period of Five years. There should be no annual escalation in AMC charges.
 - (b) Final price will be compared after adding AMC charges and deducting the buy-back offer price.
 - (c) AMC period will start after expiry of Warranty period. Payment of AMC charges will be made on half yearly basis.
 - (d) It will be at the discretion of this Secretariat to enter into AMC.
 - (e) All complaints should be attended on site within 24 hours.
 - (f) A replacement unit should be provided till the defective equipment is repaired & returned.
 - (g) Penalty for **not providing replacement unit** would be @ 1% of the cost of the equipment per day in addition to the deduction of pro-rata AMC charges for the period the equipment remains unserviceable.
 - (h) The firm will have to furnish performance bank guarantee @10% of the contract value.
14. Disputes, if any, emanating from the resultant contract will be interpreted under the Indian Laws.
 15. Sealed Tenders super scribing "HAND HELD METAL DETECTOR" complete in all respects should be submitted separately and addressed to the "Director (Security), Lok-Sabha Secretariat, Parliament House, New Delhi-110 001 and should reach this Secretariat on or before 25/02/2013 by 1300 hrs. Quotations received after due date will not be accepted.
