Clarifications on the technical specifications and terms & conditions in respect of the tender notice published on 13/04/2018 for procurement of security equipments

With reference to the tender notice published on 13/04/2018 for procurement of security equipments in The Hindustan Times, Nav Bharat Times, Central Public Procurement Portal and on the Lok Sabha website, a pre bid meeting was held on 03/05/2018 from 1500hrs to 1600hrs in PH Complex.

2. Clarifications and modifications with respect to technical specifications and terms & conditions published earlier on the Lok Sabha website in the aforementioned tender are as mentioned below:

1) Single View X-ray Baggage Inspection Systems:

Point No.13 (i)	Operating System: “Windows-8.1 or higher version compatible with the software of XBISs or Linux operating system compatible with the software of the XBISs.	All other technical specifications will remain unchanged.
Point No.15	“Idle rollers have to be provided at either end of the tunnel (input and output) to facilitate placing and retrieval of baggage. Minimum/maximum length of the input/output rollers may be approximately a minimum of ½ metre to a maximum of 1 metre depending on the availability of space at the location of installation ”

If there is any fault in the machine on Sunday/Gazetted Holiday, the engineer has to attend and rectify the fault and restore it within the permissible downtime. Preventive Maintenance will be carried out once in every 03 (Three) months.
